Norfolk County Council proposes to make a Temporary Traffic Regulation Order (the "Order") (STRO11004) affecting the A143 Scole Stuston Bypass from its junction with A140 Roundabout to its junction with C582 Bungay Road (the "Road") in the Parish of Scole to facilitate stud removal, surfacing and road marking works, the Road will be temporarily closed (except for pedestrian access) for the duration of the works only whilst signs indicating closures are in place which is anticipated to be from 3<sup>rd</sup> June to 19<sup>th</sup> July 2024, but may continue to be closed until the 19<sup>th</sup> January 2025 where the closure is still required beyond the anticipated dates.

Vehicular access will be permitted to a final destination in the Road where signs indicating such access is possible and permitted are in place.

The Order shall automatically revoke on the completion of the works when the closure is no longer necessary or otherwise on the 19<sup>th</sup> January 2025 without further notice.

If necessary, the restriction could run for a maximum period of 18 months from the date the Order is effective.

Alternative route is via: A143, A146, A140, Scole Stuston Bypass (Stockton, Framingham Pigot, Brockdish, Pulham Market, Swainsthorpe, Redenhall with Harleston, Bungay, Earsham, Ellingham, Ditchingham, Stuston, Chedgrave, Trowse with Newton, Kirby Bedon, Denton, Dickleburgh and Rushall, Yelverton, Keswick and Intwood, Broome, Stoke Holy Cross, Needham, Hellington, Hales, Scole, Tivetshall, Wacton, Gillingham, Tasburgh, Saxlingham Nethergate, Ashby St. Mary, Loddon, Long Stratton, Sisland, Thurton, Caistor St. Edmund and Bixley, Wortwell, Kirby Cane, Alburgh, Burston and Shimpling, Holverston, Newton Flotman).

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.

In the event of the start date being delayed the new start date will be displayed on site in advance.
