#### 1. To consider apologies for absence

Becky Buck, Clerk, explained why the Town Council would not be able to be the lead in running this event, this is due to the event being held in multiple locations around Long Stratton. The Town Council would be unable to secure insurance for the event whereas local businesses would have their own insurance in place for the aspects of the event that are being held on their premises. The Clerk advised that the Council although will not lead the event, will support the event in any way they can.

As this new format is well supported in the community, it was decided to go ahead with it rather than having the event in one place on the Manor Road playing fields (hard standing area).

The business owners present agreed to form a Christmas event community group and to meet in the Pavilion in two weeks time with the support of the Town Council.

It was agreed to go ahead with Friday 1<sup>st</sup> December 2023. A lengthy discussion was had on ideas including, a grotto, games, a treasure trail around the Town in all businesses who want to be involved, local stall holders who don't have their own premises being offered space to set up, outdoor bar in the local pub gardens, local food and drink, raffle tickets, Christmas tree crafts, raising money for foodbank, carol singers, running orders, Facebook group etc

The community would like more motifs. As these are very expensive the Town Council could potentially use the money allocated for Christmas to go towards these instead.

The Town Council agreed to helping with advertising and to purchase Christmas presents.

It was noted that there was not to be a Christmas tree festival in Long Stratton this year due to personal reasons.

- B.Buck to add Christmas motifs to the next Full Council agenda
- B.Buck to order road signs from TMO if needed
- B.Buck to make sure motif lights and tree lights are switched on before the event
- B.Buck to advise businesses on legalities of electrical motifs, lights etc
- B.Buck to advise businesses on who to apply to for planning permission
- B.Buck to apply for temporary events notice on businesses behalf
