Norfolk County Council (Tibenham) Urgent Notice Temporary Traffic Regulation Order 2024 Section 14(2) of the Road Traffic Regulation Act 1984

Tibenham (STRO11508) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to stud replacement the use by vehicles (of any class/specific class) of the B1134 Long Row from its junction with C350 Cherry Tree Road for 2621m eastwards (the "Road") in the Parish of Tibenham will be temporarily prohibited/restricted

The closure/restriction is necessary or expedient because works are being or are proposed to be executed on or near the Road.

The closure/restriction is anticipated to take place between 19:00 and 05:00 from 30th August to 3rd September 2024 only whilst signs indicating closures are in place.

This Notice shall be in effect from 30th August to 3rd September 2024 or until the closure/restriction no longer necessary, whichever is the earliest.

This Notice shall automatically revoke on the completion of the works when the closure/restriction is no longer necessary or otherwise on the 3rd September without further notice.

If necessary, this Notice may be extended for a maximum of 18 months from the date this Notice is effective by an Order.

Alternative route is via: Heath Road, Long Row, Station Road, Ipswich Road, Norwich Road, Old Street, Ipswich Road, Mulbarton Road, Main Road, Short Lane, The Common, The Turnpike, Market Place, Chapel Street, Marsh Lane, Castle Hill Road, Haugh Road, Mile Road (New Buckenham, Forncett, Bunwell, Pulham Market, Tibenham, Swainsthorpe, Mulbarton, Carleton Rode, Wreningham, Gissing, Old Buckenham, Winfarthing, Bracon Ash, Keswick and Intwood, Stoke Holy Cross, Tivetshall, Wacton, Ashwellthorpe and Fundenhall, Tasburgh, Saxlingham Nethergate, Long Stratton, Swardeston, Caistor St. Edmund and Bixley, Banham, Tacolneston, Aslacton, Newton Flotman).


A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/ closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
